ON THE BUSES

One of our members recently travelled interstate by coach and suffered the inevitable distress caused by the mindless and heartless tobacco burners travelling with her.

Although smoking is now banned on Sydney's public transport, it is still permitted on private bus lines.

We have contacted two major coadh operators: Pionser and Greyhound, to find out what provision they make for non-smokers.

Pioneer advised us that all seats on the left hand side of their coaches are now reserved for non-smokers.

In Greyhound coaches, the fron eight rows of stats on the left hand side are reserved for non-smokers.

The inadequacy of such provisions is obvious to anyone who has

The inadequacy of such provisions is obvious to anyone who has sat in such non-smoking areas. In reality they may as well not exist, as the bus quickly fills up with a uniform grey cloud. The idiocy of providing a non-smoking area at the front of the bus is highlighted by the fact that the drivers of both lines are permitted to smoke !

ACTION YOU CAN TAKE... Write to the Minister for Transport, Mr. Cox, requesting that smoking be banned on private bus lines. Write to your own local bus line requesting that smoking be banned.

Write to the airlines - the situation there is identical.

RESTAURANTS

The Restaurant & Catering Trades organisation was presented with a submission from our movement, asking that non-smokers be considered by the restaurant and catering fraternity as well as publishing our letter, the editor also produced his own comments under the heading "Where there is Smoke there is Trouble."

We hope that this will create some interest within the trade, and that there will be follow-ups as a result. Members should start to request non-smoking sections when visiting restaurants and bring the plight of the non-smoker to the attention of eateries. In time, if sufficient demand is seen as existing, we may be taken seriously. We also suggest that if a restaurant informs you that they do not have a non-smoking section, that you tell them you will eat elsewhere. This may help things along a bit.

OVERSEAS NEWS

Members may be interested in the terms of the Norwegian Tobacco Act of 1973 which appears to have had effect since being implemented:

1.A total ban on all advertising of tobacco products; exceptions are signboards of nominal size outside tobacco shops, whose only function is to provide information that tobacco is for sale. The ban does include indirect advertising: tobacco products must not be included in the advertising of other goods and services.

(Have you noticed the continuation of corporate advertising by companies in Australia such as Benson and Hedges, Dunhill, etc., that promotes the company, eg House of Dunhill ads, but doesn't make specific reference to their cigarettes? It is legal here. See our later item about Marlboro).

2.An obligation to label all packets with a symbol and a text pointing out the health dangers connected with digarette smoking. The text used has been: "Warning from the Directorate of Public Health: Daily digarette smoking endangers health. It may lead to serious diseases, including lung cancer and coronary heart disease. The risk increases with consumption and is greater when smoking begins at an early age. Giving up smoking reduces the risk of disease."

A new system with 16 different texts is operating today-to cover all aspects of smoking. Initiatives are also being taken to include a symbol, which will in itself become a message to the public.

3. Prohibition against selling or handing over of tobacco products to persons under 16 years of age.

It is clear that governments must accept responsibility for making the public aware of the health risks involved in smoking; and that such activities need to be sustained and revised; and not allowed to simply become another part of the scenery. Countries like Norway and France have become very active at government levels; and we would hope that the Australian government will follow suit. The World Health Organisation have stated that digarette smoking has the questionable honour of being the greatest health threat to modern man.

A letter was recieved from Dr Gwyn Howells, the Director-General of Health in response to our letter to him. He has given support to the movement, and points out a number of interesting things.

He has mentioned the dangers of contractive edicing to the introduction of his 1974-5 cannot copact, as the 1977 health Ministers! Conference, a Working Percy was course to diabe with the tobacco manufacturers to formulate an advertising code for media other than television and radius

He also reports that moves are afoot to discourage smoking in Commonwealth Government occupied buildings and that it has been banned in lifts of the Central Office buildings.

He has received strong representation from people concerned about the sponsorship of sporting events by tobacco companies, and the introduction of corporate advertising. A meeting was planned with the Minister for Post and Telecommunications, the Director of the Anti-Cancer Council of Victoria and the Minister for Health to discuss these matters, but the election has intervened.

Let's hope that this gentleman pursues these matters further and we are able to see tangible results of government measures.

FREE GOVERNMENT CIGARETTE 1?

It seems that the Minister for Youth and Ethnic Affairs, Mr Rex Jackson thinks that digarettes ought to be promoted. We have discovered that the state government gives free digarettes to persons resident in such places as mental institutions, homes, jails, etc. This seems to be a logical contradiction of these folk are being retained in these aforementioned institutions for purposes of rehabilitation, the encouragement of smeking can hardly fall into the category of self-improvement, or are we just bias? Mr Jackson?

GOOD NEWS TRAVELS FAST

POISÓN A CHILD TODAY

The only children's hospital in Sydney, The Campordown Children's Hospital has no policy of non-smoking in the Outpatients section. Our ever-zealous representatives spoke with the hospital administration and got no-where Parents were seen nursing sick children with fag in mouth. A nursing authority stated that about 75% of the children admitted are suffering from respiratory ailments. Researchers have found that children from homes where parents smoke suffer higher incidences of respiratory ailments.
